DISCIPLINARY PROCEDURES FOR THE CODE OF PROFESSIONAL CONDUCT FOR BREASTFEEDING PEER COUNSELLORS

I. Introduction

a) Breastfeeding Peer Counsellors have undergone a Breastfeeding Peer Counselling Training Course presented by La Leche League South Africa (LLSA). The ONLINE year-long program (<https://www.llsa.org/product-page/breastfeeding-peer-counsellor-online-training-program>) covers the basic tools for Breastfeeding Peer Counsellors to provide lactation support to pregnant and breastfeeding families in their own communities, and protect and promote breastfeeding. The course, compiled in 2021, used the 2020 Baby-friendly Hospital Initiative training course for maternity staff as a basis, and added material from various Peer Counsellor training courses available (LLNZ, WABA, Malaysia, Well Start, WIC and material supplied by Dilshaad Sungay - retired LLSA Leader and breastfeeding peer counsellor trainer) and is updated yearly.

b) In order to maintain and enhance the credibility of Breastfeeding Peer Counsellors, the Disciplinary Procedures to follow, allow consumers and others to bring complaints concerning Breastfeeding Peer Counsellors' conduct, to LLSA PCPA (Peer Counsellor Program Administrator). LLSA PCPA may require education, obtain written assurance of non-continuation of specified conduct, privately reprimand, publicly reprimand, suspend the Breastfeeding Peer Counsellor, or report the violation to a higher authority.

c) It should be emphasized that actions taken under these Disciplinary Procedures do not constitute enforcement of the law, although referral to appropriate government agencies, licensing bodies, or other organizations may be made about the conduct of the Breastfeeding Peer Counsellor. Individuals bringing complaints are not entitled to any relief or damages by virtue of this process, although they will receive notice of any public action taken.

d) It is up to the Breastfeeding Peer Counsellor to report the individual bringing a complaint to an appropriate* authority should she feel the need.

(*Report suspected child abuse to the police, the Child Protection Unit, or a social worker at one a local child and family welfare agencies. Severe abuse should be reported to Lifeline, Childline, or the Child Emergency Line.)

II. Complaints

a) Complaints must be signed, and valid contact information for the submitter supplied, and submitted by email to pcp@llsa.org and cc info@llsa.org and marked "BREASTFEEDING PEER COUNSELLORS CODE OF PROFESSIONAL CONDUCT COMPLAINT". During the course of the disciplinary process, a complainant's identity

may become known to the Breastfeeding Peer Counsellor who is the subject of the complaint for purposes of ensuring a fair process.

b) Anonymous complaints will not be entertained.

c) The individual filing a complaint must have direct, first-hand knowledge of the facts of a violation of one or more principles of the Code of Professional Conduct. Complaints made without sufficient evidentiary documentation, as well as those based on hearsay, may be deemed invalid. All available evidentiary documentation must be submitted with the complaint form (e.g., screen shots of social media posts, emails, photos, charting, etc.).

d) The individual filing the complaint must provide signed consent authorizing LLLSA PCPA to share with or otherwise disclose to (a) the Breastfeeding Peer Counsellor and (b) all persons with knowledge identified in the complaint all the information included in the complaint, or a summary of such information, for purposes of the disciplinary proceeding initiated against a Breastfeeding Peer Counsellors.

e) A complaint involving conviction of a crime by a Breastfeeding Peer Counsellor may not be actionable if the crime is unrelated to the practice of lactation consulting.

Before submitting a complaint, please familiarize yourself with the Disciplinary Procedures above and ensure the following requirements:

1. The only accepted method of submitting a complaint and related documentation to LLLSA PCPA is by email. Be sure to attached all evidentiary documentation.
2. Each section of the complaint-form below must be completed. Incomplete submissions will not be accepted.
3. All available evidentiary documentation must be submitted with the complaint form (e.g., screen shots of social media posts, emails, photos, charting, etc.).
4. The Complainant must be an individual, not a business or entity, and must have direct, first-hand knowledge of the facts of a Breastfeeding Peer Counsellor's violation of one or more principles of the Breastfeeding Peer Counsellors Code of Professional Conduct. Complaints made without sufficient evidentiary documentation, as well as those based on hearsay, may be dismissed.
5. LLLSA PCPA may self-initiate complaints on the basis of third-party sourced information only when the allegations pertain to egregious conduct such as abuse or significant bodily harm; all other anonymous complaints will not be entertained by LLLSA PCPA.
6. During the course of the disciplinary process, the Complainant's identity may become known to the Breastfeeding Peer Counsellor who is the subject of the complaint for purposes of ensuring a fair process.
7. A complaint involving a Breastfeeding Peer Counsellor's conviction of a crime may not be actionable if the crime is unrelated to the practice of lactation support.
8. The disciplinary process is designed to resolve only complaints concerning potential unethical conduct of a Breastfeeding Peer Counsellor within the meaning of the Code of Professional Conduct. The disciplinary process is not applicable to disputes of a commercial or personal nature, such as claims that a Breastfeeding Peer Counsellor's conduct amounted to defamation or disparagement, or to

differences in professional opinion. Such matters should be resolved without resorting to the disciplinary process. Only complaints where the major component rises to the level of unethical conduct under the Code will be considered actionable.
